CALL FOR APPLICATIONS Sustainable Leadership Learning for Climate and Disaster Risk Reduction (SLL-CDRR)

The call for the application for the Sustainable Leadership Learning for Climate and Disaster Risk Redcution (SLL-CDRR) is now open.

The SLL-CDRR is a full scholarship program specifically designed for those currently working in government and non-government offices to produce a cadre of climate and disaster resilience leaders who will be capacitated to be competent leaders in disaster risk and crisis management, specializing in climate and disaster resilience. The recipients of the scholarship will enroll in the Executive Master in Disaster Risk and Crisis Management (EMDRCM) program at the Asian Institute of Management. The SLL-CDRR is run in cooperation with the Climate Change Commission, with support from the Office of Senate President Pro Tempore Loren Legarda

TARGET SECTORS

- Disaster Risk Reduction and Management Officers in local and national government units, the backbone of disaster response and rehabilitation efforts;
- Women leaders, recognizing their unique perspectives and experiences in addressing the gender dimensions of the global climate emergency;
- · Leaders from indigenous groups, the guardians of our environment; and
- · Sustainability champions in local and national government agencies.

ELIGIBILITY REQUIREMENTS

- 1. The applicant must come from the target sectors/categories (see above).
- 2. Must have a Bachelor's degree
- 3. At least three years' work experience, preferably with a minimum of two years' managerial experience; and
- 4. Proficiency in oral and written English.

APPLICATION PROCESS

- 1. Fill out the application form accessible at https://aim.edu/admissions/application-form
- 2. Send the following documents to emdrcm@aim.edu:

Basic Application Requirements:

- A. Updated Curriculum Vitae
- B. Copy of Diploma (Certified True Copy)
- C. Copy of undergraduate Transcript of Academic Records (TOR) or mark sheet
- D. A Letter of Motivation
- E. A valid government ID (passport ID page is preferred)

Requirements for applicants from local and national government agencies:

- A. Certification from the Head/Chief of the Human Resource Division/Unit/Office stating the nominee has:
 - a. no pending administrative or criminal case;
 - b. no pending nomination in another scholarship program; and
 - performance ratings for the two (2) consecutive semesters immediately
 preceding the nomination were at least Very Satisfactory (or equivalent).

- B. Most recent Appointment Letter;
- C. Statement of the nominee's currrent duties and responsibilities;
- D. Service Record;
- E. Personal Data Sheet as of the date of application/nomination;
- F. Copy of Agency ID and any government issued ID (if applicable);
- G. Clearance document from Ombudsman and National Bureau of Investigation (completed within the last 6 months);
- H. Medical Certificate (fit to study as certified by a licensed physician);
- I. Two (2) 2"×2" photos; and
- Self-certification of no pending scholarship application/s or declaration of ongoing scholarship application/s.
- All submitted documents will be reviewed and evaluated by the AIM Recruitment and Admissions Office, and all qualified applicants will be notified to undergo a Program Overview Session via Zoom with the Student Recruitment Senior Supervisor.
- 4. An applicant who passes the initial screening will be endorsed to the AIM faculty for an admission interview.
- Applicants who pass the admissions interview will be assisted in booking the NMAT Exam. The NMAT, provided by GMAC, assesses skills required for academic success in graduate programs, particularly language skills, quantitative ability, and logical reasoning.
- After receiving the NMAT result, the applicant must submit a copy of the scorecard to AIM Recruitment and Admissions Office.
- 7. The AIM Recruitment and Admissions Office will endorse those qualified to the Climate Change Commission for final selection and approval.
- 8. The release of results of the scholarship application will be sent via email.

Application for scholarship is open until 15 April 2024.
