This has reference to our recently concluded meeting wherein it was agreed that a memorandum shall be distributed to each member agencies regarding the discovery of twenty-four (24) packs of transparent plastic containing white crystalline substances in the shoreline of San Juan, Ilocos Sur, Ilocos Region. Attached herewith are the photographs on the seized illegal drugs.

Considering that Western Visayas is an archipelagic island, it is imperative on the member agencies especially those who are in charge in the control and security of our coastal areas to strengthen and maintain close coordination with each other to deter the new modus operandi of using the high seas as dropping point of illegal drugs. Likewise, to further avoid this strategic plan, the member agencies who has control and supervision on the barangay officials in the fishing villages as well the fishermen association and fishing communities in their respective area of responsibility should raise awareness and vigilance on the floating debris in the sea which might contain illegal drugs.

Each member agencies are encouraged and expected to do their active part in restraining the evolution of this new scheme for the safety of the people and the community against the proliferation of illegal drugs.
