## Private Schools and School Administrators Association of the Philippines

#### REGIONAL PRISSAAP YOUTH CONGRESS

#### General Guidelines

- 1. Student participants will wear their school uniform on the first day of the congress.
- Each school will bring their SCHOOL BANNER to be used during the opening program.
- 3. Each participant should bring his/her school identification (ID) card.
- 4. Each participant should submit the parent's/guardian's waiver to his/her respective school.
- A student is allowed to join in TWO contest only except for ZUMBA Competition which will be held in the morning of the second day. Failure to do so is a ground for disqualification.
- The participant should be a bona fide student and currently enrolled in a private schools for School Year 2024-2025.
- 7. The student should be a registered participant of the Youth Congress.
- 8. Ranking system should be used in identifying the winner of every contest. In case of a tie, the chief judge has the right to break the tie.
- 9. Always follow the rules and mechanics of the different contests. Failure to observe the said rules and mechanics is a ground for disqualification.

#### Rules, Mechanics and Criteria

#### Zumba (Dance Fitness Competition)

- 1. There should only be one competing group per school.
- 2. The group must be composed of 20-25 learners per school, either all males or females or mixed.
- 3. The students composing the group should be registered participants of the congress.
- 4. The teacher chaperone, trainer, dance/Zumba master and/or adviser are not allowed to join the group.
- 5. The participants should wear appropriate Zumba attire.
- 6. The music should not be less than 2 minutes and not more than 3 minutes. One (1) point will be deducted from every judge's total score for every 30 seconds less and/or 30 seconds exceeding the time limit.
- 7. The music can either be one entire song or mixed.
- 8. The music should be ready 10 minutes before the performance.
- 9. The music must be accurately cued up for playing.
- 10. The music could either be in a CD or cellphone, ipad, or tablet copy.
- 11. No props allowed.
- 12. All elements (warm-up, dance proper, cool down) of Zumba must be observed.
- 13. The participants should be present 20 minutes before the contest for briefing and instructions.
- 14. Drawing of lots will be done a day before the Zumba and to be announced during the congress.
- 15. The decision of the judges is final and irrevocable.

#### Poem/Essay Writing in English & Filipino

Only one (1) participant coming from each school.

The general theme of the writing contests focuses on the congress theme. Final topic will be given by the organizers during the contest proper.

One hour is allotted to write the essay.

Paper shall be provided. The participants shall bring their own pens/ball pens during the contest. No SCRATCH PAPERS whatsoever may be brought in the contest room.

The decision of the board of judges is final.

#### **Choral Singing Contest**

Only one (1) group participant coming from each school. The group must be composed of a minimum of fifteen (15) and a maximum of twenty five (25) members, either all males, all females or mix.

The piece must be a composition of a Filipino composer in Filipino or English. A hard copy of the lyrics of the song (3 copies, short sized bond paper) should be submitted to the committee an hour before the contest.

The group must be accompanied by a CD or any musical instrument/accompaniment to be used during the performance.

A cappella singing is allowed.

There shall be no time limit in the performance.

The decision of the board of judges is final.

#### **Dance Sports**

- 1. There will be only one couple (male and female) coming from each school.
- 2. Latin American is the category of the competition which is composed of:
- a. Cha cha cha
- c. Rhumba
- c. Jive

b. Samba

- d. Paso Doble
- 3. Each dance must be executed in one and half (1½) minutes except for jive which must be executed in a minimum of one (1) minute.
- 4. Use of religious symbols as decoration or jewelry is not allowed.
- 5. A couple who bumps into another couple or stumble down during the competition will be disqualified in the contest.
- 6. The line direction should be followed during the competition especially in Samba.
- 7. The judging of the couple begins when they adopt their dancing position and ends only when the music stops. The judges must only check their marks during the entire dance and amend them if necessary.

- 8. If the couple stops dancing while the music is still being played, the couple will be ranked last in the dance. If this happens during the final round, the couple will be rank last in the dance.
- 9. Couples must be judged solely on their performance in the specific dance at the specific time.
- 10. Attire:

Ladies:

The area between the hip and the panty line, plus the back and breast must be covered. No see-through materials are allowed on these areas. No high-cut panties, tangas.

When standing, the skirt should cover the panties completely.

Any color, except flesh (skin color) is allowed.

Panties have to be black or the same color of the dress.

Gentlemen:

Black or midnight blue trousers. Black or midnight blue or white shirt on top. Any other top is allowed if it is the color of the material of the lady's dress. The shirt or top has to be tucked ion. No sleeveless shirt or tops are allowed.

The shirt can be open down to the end of the breastbone. See through materials can be used as decoration but not as the basic material.

Vest, jacket or bolero of the same color of trousers is optional.

Tie, bow tie or scarf matching the trousers of the top is optional. If the scarf is worn, it has to be tied and tucked inside the shirt.

Combinations of different materials of the same color are allowed.

Short hairstyle is preferred.

- 13. Non-adherence to the attire rule would mean disqualification.
- 14. The decision of the board of judges is final.

#### **Interpretative Dance**

The dance is to be performed by a minimum of 10 and a maximum of 16 members, either all males, all females or mixed.

One entry is allowed per school.

The dance to be performed must either be a combination of modern, ethnic, jazz and other dances.

There should be a storyline in the presentation of the dance which is relevant to the congress's theme.

Props should be light and handy. Use of party spray in any form or party popper is not allowed during the performance.

Costume should be decent and presentable.

Any of the following media may be used for music accompaniment: USB, tablet or cell phone copy.

Performance should not exceed seven (7) minutes.

Entrance and exit steps/figures are still part of the performance, thus included in the seven (7) minutes time limit.

If the group exceeds in the allotted time, 1 point deduction (from every judge's total score) for every 10 seconds is given.

The decision of the judges is final.

- 1. Only one (1) participant coming from each school.
- 2. The piece must be a composition of a Filipino composer in Filipino or English. A hard copy of the lyrics of the song (3 copies, short sized bond paper) should be submitted to the committee an hour before the contest.
- 3. The soloist must be accompanied by any of the following media: USB, tablet or cell phone copy.
- 4. There shall be no time limit in the performance.
- 5. Attire is decent and presentable. There should be no school identification.
- 6. The decision of the board of judges is final.

- 3. The soloist may have any of the following media used for music accompaniment: USB, tablet or cell phone copy.
- 4. There shall be no time limit in the performance.
- 5. Attire is decent and presentable. There should be no school identification.
- 6. The decision of the board of judges is final.

#### **Acoustic Duo**

- 1. Only one pair (1) participant coming from each school. It can either be all male or female or a combination of both.
- 2. They should be accompanied by a guitar. It can either be one partner or both of them will play the guitar. For the vocals, it can either be only one partner or both of them will sing.
- 3. The piece must either be foreign or an OPM composition. Only one complete song is allowed. Mashed-song type is not allowed.
- 4. There shall be no time limit in the performance.
- 5. Attire is decent and presentable. There should be no school identification.
- 6. The decision of the board of judges is final.

#### Acoustic - Solo

- 1. There should only be participant coming from each school.
- 2. The contestant should be the one playing the guitar as an accompaniment of his/her contest piece.
- 3. The piece is either foreign or an OPM composition. Only one complete song is allowed. Mashed-song type is not allowed.
- 4. There shall be no time limit in the performance.
- 5. Attire is decent and presentable. There should be no school identification.
- 6. The decision of the board of judges is final.

#### **Hip Hop Dance**

Only one (1) group coming from each school. The group must be composed of a minimum of six (6) and a maximum of twelve (12) members, either all males, all females or mix.

Combination of dance songs is allowed as long as the performance should not exceed seven (7) minutes.

If the group exceeds in the allotted time, 1 point deduction (from every judge's total score) for every 10 seconds is given.

Any of the following media may be used for music accompaniment: USB, tablet or cell phone copy.

Props should be light and handy. Use of spray in any form or party popper is not allowed during the performance.

Costumes should be decent and presentable.

Appropriate gestures and steps or choreography is a must.

Dangerous stunts and head spins are strongly discouraged.

The decision of the board of judges is final.

#### **Verse Choir**

#### Official Piece:

- 1. Only one (1) group coming from each school. The group is composed of minimum of fifteen (15) and a maximum of twenty five (25) members, either all males, all females of mix.
- 2. The group must present an excerpt from the official piece.
- 3. The delivery of the piece should not exceed ten (10) minutes. Entrance and exit are part of the time limit.
- 4. If the group exceeds in the allotted time, 1 point deduction (from every judge's total score) for every 10 seconds is given.
- 5. Props are allowed as long as they are handy and portable. Use of spray in any form or party popper is not allowed during the performance.
- 6. Costumes should be decent and presentable.
- 7. Conductor/conductress is allowed.
- 8. The decision of the judges is final.

#### **Poster Making**

- 1. Only one (1) participant coming from each school.
- 2. The general theme of the Poster Making focuses more on the congress's theme.
- 3. One hour and a half is allotted to do the poster making. If a participant can't finish his/her work after the allotted time, he/she will be disqualified.
- 4. Any coloring materials are allowed. Combination of different mediums is allowed.
- 5. The participant should provide his/her own materials. 1/8 size illustration board (has the option if the participant will use the white or the black portion) and coloring materials.
- 6. The decision of the board of judges is final.

#### Lip Synchronization

- 1. Only one participating group per school.
- 2. Participating group should have a minimum of 5 and maximum of 8 members, either all males, all females of mix. No cross-dressing is allowed.
- 3. Costume must be appropriate. There should be no obscene gestures or improper conduct during the presentation. No cross-dressing is allowed.
- 4. The group is free to choose any piece; English, Filipino or any language.
- 5. Only one song is allowed. No mashed or mixed song is allowed.
- 6. The performance must not exceed 5 minutes; however, one (1) point will be deducted from every judge's total score for every 20 seconds exceeding the time limit.
- 7. Three copies of the lyrics of the song/piece should be submitted to the committee an hour before their performance.
- 8. Use of props is allowed as long as these props are light and handy.
- 9. Use of spray in any form or party popper is not allowed during the performance.
- 10. Any of the following media may be used for music accompaniment: USB, tablet or cell phone copy.
- 11. In case of a tie, the chief judge will break the tie.

#### REGIONAL PRISSAAP YOUTH CONGRESS for Visayas

#### General Guidelines

- 1. Student participants will wear their school uniform on the first day of the congress.
- 2. Each school will bring their SCHOOL BANNER to be used during the opening program.
- 3. Each participant should bring his/her school identification (ID) card.
- 4. Each participant should submit the parent's/guardian's waiver to his/her respective school.
- 5. A student is allowed to join in TWO (2) contests ONLY except for ZUMBA Competition which will be held in the morning of the second day. Failure to do so is a ground for disqualification.
- The participant should be a bona fide student and currently enrolled in a private school for School Year 2024-2025.
- 7. The student should be a registered participant of the Children's Congress.
- 8. Ranking system should be used in identifying the winner of every contest. In case of a tie, the chief judge has the right to break the tie.
- 9. Always follow the rules and mechanics of the different contests. Failure to observe the said rules and mechanics is a ground for disqualification.
- 10. All participants are required to attend the plenary sessions and workshop activities.

#### Rules, Mechanics and Criteria

#### Zumba (Dance Fitness Competition)

- 1. There should only be one competing group per school.
- 2. The group must be composed of 20-25 learners per school, either all males or females or mixed.
- 3. The students composing the group should be registered participants of the congress.
- 4. The teacher chaperone, trainer, dance/Zumba master and/or adviser are not allowed to join the group.
- 5. The participants should wear appropriate Zumba attire.
- 6. The music should not be less than 2 minutes and not more than 3 minutes. One (1) point will be deducted from every judge's total score for every 30 seconds less and/or 30 seconds exceeding the time limit.
- 7. The music can either be one entire song or mixed.
- 8. The music should be ready 10 minutes before the performance.
- 9. The music must be accurately cued up for playing.
- 10. The music could either be in a CD or cellphone, ipad, or tablet copy.
- 11. Props in all forms are not allowed.
- 12. All elements (warm-up, dance proper, cool down) of Zumba must be observed.
- 13. The participants should be present 15 minutes before the contest for briefing and instructions.
- 14. Drawing of lots will be done a day before the Zumba and to be announced during the congress.
- 15. The decision of the judges is final and irrevocable.

Panties have to be black or the same color of the dress.

#### Gentlemen:

Black or midnight blue trousers. Black or midnight blue or white shirt on top. Any other top is allowed if it is the color of the material of the lady's dress. The shirt or top has to be tucked in. No sleeveless shirt or tops are allowed. The shirt can be open down to the end of the breastbone. See through materials can be used as decoration but not as the basic material. Vest, jacket or bolero of the same color of trousers is optional. Tie, bow tie or scarf matching the trousers of the top is optional. If the scarf is worn, it has to be tied and tucked inside the shirt. Combinations of different materials of the same color are allowed. Short hairstyle is preferred.
