2024 INTERNATIONAL COASTAL CLEAN-UP & SCHOOL CLEAN-UP DAY SUBJECT:

- 1. Presidential Proclamation No. 470 series of 2003, declared the Third (3rd) Saturday of September of each year as the "International Coastal Clean-Up Day". This year's International Clean-Up will be celebrated on the third Saturday of this month September 21, 2024.
- 2. International Coastal Clean-up & School Do Day aims to engage people around the world to remove trash and debris from beaches, waterways, and other water bodies to identify the sources of the litter, to change behaviors that cause pollution, and raise awareness on the extent of the marine debris problem.
- 3. Taking into consideration the Environment Educational and Sustainability program of the Boy Scouts of the Philippines, all Scouts and Scout Leaders are encouraged to initiate the conduct of clean-up drive activity cleaning and collecting the trash that pollutes our waterways at homes and within school areas.
- 4. Documentary and pictorial indicating the actual clean-up drive shall be uploaded to https://bit.ly/CoummnityServiceReport and https://sites.google.com/site/icephilippines/home.
- 5. Please wear your Scout uniform and neckerchief during the conduct of the activity.
- 6. Download the Clean Swell app http://sites.google.com/site/iccphillippines/about-icc/clean-swell-app on your mobile phone. This app is simply "Start Collecting" trash wherever you are around the world and the data you collect will instantaneously upload to Ocean Conservancy's global ocean trash database. These data deliver a global snapshot of ocean trash, providing researchers and policy-makers insight to inform solutions.
- 7. Scouts and Scout Leaders who will be participating and taking part on the said activity will get their certificate of participation at https://sites.google.com/site/icephilippines/download.
