For Grade 10 students, we offer an accessible Senior High School program:

- ₱200 downpayment
- No additional fees
- Free 1 set of school uniforms
- Automatic Senior High School Voucher (amounting to ₱20,000) for public school completers
- Automatic HK7.5 scholarship for college (*applicable to any course without the need for grade maintenance*)
- No entrance examinations
