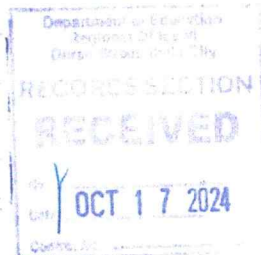

In celebration of its 60th Anniversary, the University of the Philippines National Institute for Science and Mathematics Education Development (UP NISMED) will be hosting an International Conference on Science, Technology, Engineering, and Mathematics (STEM) Education (ICSTEM) on November 22–23, 2024 at the UP NISMED Auditorium, UP Diliman, Quezon City.

The ICSTEM 2024 conference aims to bring together the participants to share and discuss ideas, research findings, and initiatives that contribute to the advancement of STEM education.

With the theme, Advancing STEM Education through Emerging Technologies, Innovative Pedagogies, and Responsive Curricula, the Conference will focus on the following sub-themes:

1. Emerging Technologies in STEM Education,
2. Innovative STEM Pedagogies,
3. STEM Education and Transformative Leadership,
4. STEM Education for Sustainable Futures,
5. STEM Curriculum Reforms and Policy, and
6. Assessment in STEM Education.

The target participants are educators, researchers, policymakers, teachers, and learners from around the world.
