IMPLEMENTATION OF PROJECT "DOSA": (DIGITALIZATION OF ISSUANCES OF SUB-ALLOTMENT RELEASE ORDER (SUB-ARO) FOR SECONDARY SCHOOLS IMPLEMENTING UNITS

- 1. Relative to Regional Memorandum No. 175, s. 2021 titled "Institutionalization of Educational Innovation in Region VI Western Visayas", this Office announces the implementation of Project DOSA (Digitalizaton Issuances of Sub-Allotment Release Order (Sub-ARO) for Secondary Schools Implementing Units starting this Fiscal Year 2024.
- 2. Project DOSA will work on the digitalization of issuances of Sub-ARO for secondary schools implementing units to provide easy access to information related to releases of additional funds. This project aims to:
 - a. create an online support system to facilitate effective communication between the Budget Section and schools, ensuring that schools are well-informed about additional fund releases;
 - b. automate processes of releasing Sub-ARO to schools, leading to faster distribution and utilization of funds;
 - c. produce a shared database system where schools can securely download their Sub-ARO, ensuring easy and safe access to fund release documents and will also serve as digital archive of their fund releases; and

- d. ensure timely and accurate recording in the Budget Monitoring System, thereby preventing delays in the consolidation and submission of monthly and quarterly accountability report.
- 3. This project, will use online platform to set up an online network of all secondary school accountants/bookkeepers where all updates pertaining to additional PS and MOOE releases will be posted. A Sub-ARO Data Base system will be provided that will serve as the digital archive of all the fund releases.
- 4. Anent this, all school administrators and accountants/ bookkeepers of secondary schools implementing units are advised to access and utilize the digital archive as platform for posting real-time updates regarding the fund releases.
