Mental health promotion and prevention interventions for adolescents aim to strengthen an individual's capacity to regulate emotions, enhance alternatives to risk-taking behaviors, build resilience for difficult situations and adversities, and promote supportive social environments and social networks (WHO, 2020). Social support is a crucial protective mechanism against depression and anxiety across ages, domains, cultures and risk factors.

Functional support groups mitigate the end effects of mental health problems among the youth. Youth support groups managed by a trained peer facilitator provide an avenue for the youth to share and arrive at solutions together to frequently encountered issues and concerns in their life stage, and receive the perceived psychosocial support from their peers.

In order to capacitate our peer facilitators, the Capiz Provincial Health Office will be conducting a livein Training of Trainers for Peer Facilitators on AUGUST 7-9, 2024 at Circulo Convention Center, Pueblo de Panay, Roxas City.
