In relation to the increasing number of requests for a Negative Sub-ARO to withdraw the unobligated balances for various CY 2023 Centrally Managed Programs (CMPs), this advisory is being issued to inform all Program Teams, Regional Offices (ROs), Schools Division Offices (SDOs), and Implementing Units (IUs) that Sub-AROS with less than P50,000.0 balances will not be negated, thus, balances can still be used for the same purpose.

Anent this, all concerned offices are reminded to prioritize utilizing the said balances since the requests are charged under CY 2023 funds which are valid only until December 31, 2024.

Further, the Finance will endorse requests to the concerned Offices for concurrence before the issuance of negative sub-ARO.
