The Regional and Schools Division Offices (ROs and SDOs) are hereby directed to process the payment of Special Hardship Allowance (SHA) to eligible teachers for Fiscal Year (FY) 2024 with reference to the Department Memorandum No. 045, s. 2024 titled the Adoption of DepEd Order No. 017, s. 2023 as Guidelines for the Provision of Special Hardship Allowance for Public School Teachers issued on 12 August 2024.

The official list of hardship posts for FY 2024 is provided as revised Annex A in DepEd Order (DO) No. 017, s. 2023 titled Amendment to DepEd Order No. 039, s. 2021 (Guidelines on the Provision of Special Hardship Allowance for Public School Teachers).











Further, this is to reiterate the eligibility criteria for SHA as articulated in Section 3.0 of the DBM-DepEd Joint Circular No. 1, s. 2021 titled Revised Guidelines on the Grant of Special Hardship Allowance and Section 5.1 of DO 039, s. 2021, the following DepEd personnel are qualified to receive the SHA:

- 1. All teachers in elementary and secondary schools located in hardship posts as determined by the hardship index (HI);
- 2. Multi-grade teachers in pure multi-grade schools;
- 3. Mobile teachers and Alternative Learning System (ALS) coordinators concurrently handling ALS classes; and
- 4. School heads assigned in hardship posts or pure multi-grade schools.

> ADOPTION OF DEPED ORDER NO. 017, s. 2023 AS GUIDELINES FOR THE PROVISION OF SPECIAL HARDSHIP ALLOWANCE FOR PUBLIC SCHOOL TEACHERS

- 1. Pursuant to the Department of Budget and Management (DBM) and Department of Education (DepEd) Joint Circular No. 1, s. 2021 titled Revised Guidelines on the Grant of Special Hardship Allowance (SHA), DepEd issued DepEd Order (DO) No. 039, s. 2021 titled Guidelines on the Provision of Special Hardship Allowance for Public School Teachers which established the use of the Hardship Index (HI) for schools to identify hardship posts.
- 2. By virtue of providing additional support for teachers, DO 017, s. 2023 or the Amendment to DepEd 039, s. 2021 was issued to lower the HI cut-off from 0.37 to 0.33, allowing an increase in the number of teachers eligible to receive the SHA.
- 3. Awaiting the development of new guidelines for SHA, the Department issues this DepEd Memorandum, adopting DO 017, s. 2023 as the prevailing guidelines for SHA implementation for Fiscal Year (FY) 2024 and FYs thereafter, or until the issuance of a new policy on the matter.
- 4. All other provisions in DO 039, s. 2021 not affected by DO 017, s. 2023 shall remain in effect.
- 5.
