Under Executive Order No. 64, s. 2024, signed by President Ferdinand Marcos Jr., starting 2025, the government will provide an annual medical allowance of up to Php 7,000 to eligible government civilian personnel, including public school teachers. This allowance is intended to subsidize the cost of health maintenance organization (HMO)-type benefits. The medical allowance can be used for various medical services, helping public employees be prepared for any health-related emergencies.


