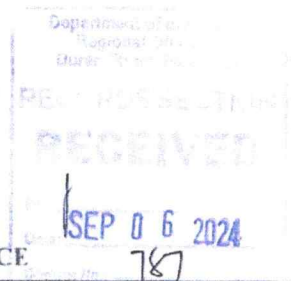

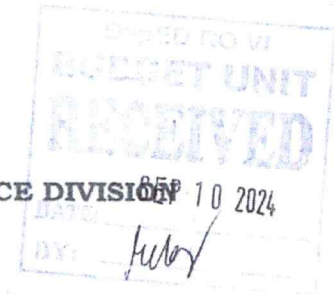

The following directives are hereby issued concerning the processing and release of the FY 2024 Grant of World Teachers' Day Incentive Benefit (WTDIB) amounting to One Thousand Pesos (Php 1,000.00) for each eligible public school teacher, pursuant to DepEd Special Provision No. 18 under Republic Act No. 11975 or the Fiscal Year (FY) 2024 General Appropriations Act (GAA):

1. Department of Education Order No. 029, series of 2020, titled "*Guidelines On The Grant Of World Teachers Day Incentive Benefit*" dated September 23, 2020, provides that the WTDIB shall be given to all public teachers, with permanent and provisional appointment, in all public elementary, junior, and senior high schools, and community learning centers, who are in service in DepEd on or before October 05 of the current school year (SY);
2. Implementing units of the Department with available cash allocations may begin processing the WTDIB of **One Thousand Pesos (Php 1,000.00)** and **ensure that all eligible teaching personnel shall receive it during the World Teachers' Day celebration**; and
3. Details regarding scope and eligibility, exemptions, implementing guidelines, and other relevant matters are indicated in DepEd Order No. 029, s.2020.
