Originality/Indicates the significance of the study and its implications for practice.

Introduction-include a brief review of literature and research questions

Methods-includes research design sampling, data collection, analysis, and ethical issues

B. Submission of Entries for Best Research e-Poster

- 1. Entries are open for the 20222-2023 BERF funded completed research.
- 2. Each district shall endorse/nominate one (1) completed research paper for the research e-poster separately from the entry for 3 best research paper and oral presentations.
 - 3. Thee-poster research entry shall conform with the following guidelines:
 - a. The e-poster shall be only one-page in A4 size and in portrait orientation for prejudging to select the top 10 qualifiers.
 - b. The Schools Division Offices shall submit their endorsed eposter research entry in **JPEG file** via Google Drive on or before November 24, 20
 - c. The top 10 qualifiers for the research e-poster shall be printed in
 - 6.25x2.75 ft one-page tarpaulin and in portrait orientation. Each district with a qualified e-poster shall provide its standee appropriate to the tarpaulin size for display purposes and oral presentation.
