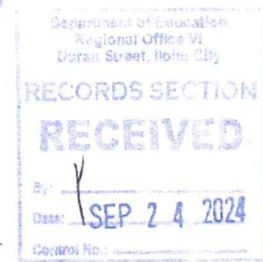

The Association of Special Libraries of the Philippines, Inc. (ASLP) is a non-stock, non-profit professional organization composed of special librarians from government institutions, private sectors, business community and the academe. Its objectives include helping librarians improve its services and stimulating the professional enhancement of its members by providing continuing education for librarians and other personnel of special libraries.

This year, ASLP will conduct its 11th National Congress with the theme *Navigating the Future: Strategies for Advancing Libraries and Information Centers in the Dynamic Landscape of Asia and the Pacific* on 16-18 October 2024 at The Victoriano J. Rodriguez (VJR) Hall, Palawan Provincial Capitol, Puerto Princesa City, Palawan.
