**LITERACY AND NUMERACY SHOWDOWN**

1. In line with the implementation of Project Prioritizing Literacy and Numeracy (**PLN**) and to address the gap and learning issues related to literacy and numeracy, this office, through the Curriculum Implementation Division (CID) will conduct the Literacy and Numeracy Showdown on November 22, 2024. The venue will be announced in a separate memorandum.
  2. This activity aims to:
    - a. establish a mechanism to capture the scenario of the Division's Literacy and Numeracy initiatives and to gauge the impact on the learners' performance of the priority schools;
    - b. provide opportunities for the priority schools to share success stories, effective ways, unique features, processes, and strategies in implementing the literacy and numeracy programs; and
    - c. give access to other school heads to learn and adopt interventions applicable to their own setting.
  3. The participants to this activity are the Education Program Supervisors in all learning areas, Public Schools District Supervisors, Central School Principals, Secondary School Heads, Integrated School Heads and District Coordinators of Mathematics, English and Filipino.
  4. Prior to the conduct of the activity, an orientation session for the PLN recipient schools, Education Program Supervisors and Public Schools District Supervisors will be conducted on November 18, 2024 at a venue that will be announced later where the mechanics and guidelines on the conduct of the showdown will be discussed.
  5. Expenses relative to the conduct of the Literacy and Numeracy Showdown will be charged against National Learning Camp (NLC) fund subject to the usual accounting and auditing rules and regulations.
