- 1. Pursuant to Section 139(a), Rule XIII (Responsibilities of the Human Resource Officer) of the Omnibus Rules on Appointment and other Human Resource Action (OR-OHRA) which provides for the Submission to the CSC Field Office concerned within the first quarter of the year the agency's updated Personnel Services Itemization/ Plantilla of Personnel, all Administrative Officers II (AO II) or assigned Non-Teaching Personnel are directed to update their Local Plantilla.
- 2. The submission of plantilla is crucial in ensuring the accuracy and completeness of the Division Human Resource Plantilla database and will be used for the pre-validation of Performance-Based Bonus 2023.
- 3. Assigned elementary school AO II are requested to consolidate the report of their district while assigned Non-Teaching Personnel for secondary school shall submit per school, using the template available for downloading at <a href="https://bit.ly/PLANTILLA\_2024">https://bit.ly/PLANTILLA\_2024</a>. The consolidated plantilla (Excel file) should be submitted via email to <a href="mailto:sdocapiz.hr@deped.gov.ph">sdocapiz.hr@deped.gov.ph</a>. Approved IPCRF (Part I-IV) for SY 2023-2024 shall be accomplished per personnel using the link <a href="https://bit.ly/IPCRF\_SY2324">https://bit.ly/IPCRF\_SY2324</a>. Deadline for submission will be on <a href="mailto:January31">January31</a>, 2024.
- 4. It is imperative that no eligible personnel is left behind. Personnel who are eligible but have transferred to other schools and divisions must be duly communicated and accounted for.
- 5. Immediate dissemination of and strict compliance with this Memorandum are desired.
