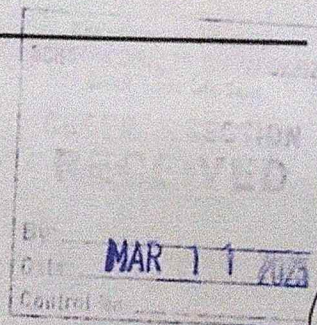

In order to avail the free medical services offered by PhilHealth Konsulta Package, eligible members must be profiled by the accredited PhilHealth Konsulta Provider.


In response to this challenge, the Roxas City Health Office intensifies its campaign for enrollment and profiling of all eligible PhilHealth members in different barangays of Roxas City.
