### ENSURING THE SAFE RETURN OF LEARNERS FOR SCHOOL YEAR 2025-2026

To: Schools Division Superintendents All Others Concerned

- 1. To ensure adherence to the MATATAG Education Agenda specifically on taking good care of learners by promoting their well-being and providing a positive learning environment, this Office requests the SDOs to follow the guidelines to ensure the safe return of learners for School Year 2025-2026, such as but not limited to:
  - protect learners from abuse, violence, exploitation, discrimination, bullying, and other forms of abuse by strictly implementing DepEd Order No. 40, s. 2012 titled DepEd Child Protection Policy, Regional Memorandum No. 386, s. 2025 titled Standardized Protocols for Handling Bullying and Child Abuse Cases, Regional Memorandum No. 182, s. 2024 titled Reiteration of Strict Compliance with Department of Education (DepEd) Order No. 55, s. 2013, titled Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 10627, otherwise known as the Anti-Bullying Act of 2013;
  - ensure that healthy and nutritious food and beverages are available to learners in compliance with DepEd Order No. 13, s. 2017 titled Policy and Guidelines on Healthy Food and Beverage Choices in Schools and in DepEd Offices;
  - enjoin compliance with DepEd Order No. 18, s. 2015 titled DepEd Guidelines and Procedures on the Management of Children-at-Risk (CAR) and Children in Conflict with the Law (CICL) and ;
  - provide necessary medical assistance and intervention to learners showing signs and symptoms of illnesses and/or sickness; and
  - request assistance from local law enforcement entities to ensure peace and order within the vicinity of the schools.
