- 1. In reference to the Memorandum DM-OUHROD-2025-1307, titled **Training on the Strengthened Senior High School (SSHS) Curriculum for Teachers of Pilot Schools, dated 22 May 2025, and National Educators Academy of the Philippines (NEAP)** advisory dated June 2, 2025, this Office, through the Curriculum Implementation Division, will conduct the Mid-Year Program Implementation Review on the Strengthened Senior High School Curriculum for Grade 11 Teachers and School Leaders of Pilot Implementing Schools on November 14 -15, 2025. The participants in this activity are the SHS grade 11 teachers, SHS coordinators, the program management team, and school leaders of the three pilot implementing schools, as follows: Ivisan NHS, Florentina B. Degala NHS, and Pontevedra Christian School. The first meal is morning snacks on November 14, 2025 and the last meal is afternoon snacks on November 15, 2025.
