- 1. Relative to Memorandum DM-OULS-2025-072 titled Guidelines on the Implementation of Safe Spaces, Strong Minds: Capacity Building for Guidance Designates, this Office, through the Human Resource Development Division shall conduct the **Regional Training on Safe Spaces, Strong Minds: Capacity Building for Guidance Designates** on **November 16-21, 2025**, inclusive of travel time, in Bacolod City.

 - Must be a PRC-licensed Professional Teacher and/or a Registered Guidance Counselor;
 - Must hold at least a full-fledged Master's degree in a related field;
 - A Guidance Designate-Teacher/Education Program Supervisor for Vaues Education or Guidance/Teaching related personnel assigned to carry out guidance services; and
 - Have not participated in the national Specialized Training for Guidance Designate.
