The Department of Education Regional Office VI, in partnership with the National Association of Public Secondary School Heads, Inc. and the Philippine Elementary School Principals Association, shall conduct the **1st Regional Assembly for Education Leaders (RAEL)** on August 18–20, 2026, at the Iloilo Convention Center, Mandurriao, Iloilo City, with Day 0 (Registration) scheduled on August 17, 2026.

2. The RAEL serves as a premier gathering of educational leaders in Region VI that aims to strengthen instructional leadership, organizational excellence, and collaborative governance by providing participants with opportunities to engage with distinguished education leaders, policymakers, governance experts, and practitioners. e. inspire school leaders through meaningful discussions and engagements with distinguished resource speakers and education leaders.

4. The participants in this activity are the Schools Division Superintendents, Assistant Schools Division Superintendents, Chief Education Supervisors, Education Program Supervisors, Public School District Supervisors, **all** Public Elementary and Secondary School Heads (including the Assistant Principals), and School Heads of Private Schools, who are highly encouraged to participate.

5. The activity shall be conducted on a live-out basis. A registration fee of Six Thousand Five Hundred Pesos (P6,500.00) shall be charged to each participant to cover meals, conference materials, conference kits, venue expenses, and other administrative and operational costs necessary for the conduct of the activity.

7. The Matrix of Activities, including the detailed program of events, and the composition of the Technical Working Group for the conduct of the activity shall be issued under a separate Regional Memorandum.
